HOUSE RULES  
Raffle License #C31214

These House Rules are effective as of August 8, 2023.

Grand prize raffle drawing will be conducted on December 9<sup>th</sup>, 2023 between approximately 6:00pm and 8:00pm EST.

**Eligibility**

Purchasers of raffle tickets must be legal residents of the United States and at least 18 years of age at the time of the purchase. The winner must supply his/her social security number to receive the winning prize. If an entrant's check or credit card is dishonored prior to the drawing, the entry ticket will be declared invalid. A "purchase" shall not occur and be binding until funds received for the same have cleared the bank. Credit cards accepted are Visa and Mastercard. Tickets may be purchased from the Oxford Wildcat Boosters website at [www.oxfordwildcatboosters.com](http://www.oxfordwildcatboosters.com), or in person, or by mail at the following address: Oxford Wildcat Boosters Club, PO Box 376, Oxford, MI 48371.

The nine (9) current Board members of the Oxford Wildcat Booster Club Inc are not eligible to be an entrant in the raffle.

**Ticket Price and Entrant Rules**

The price of a single ticket is \$75 each, or 2 for \$125, or 4 for \$200. There will be a maximum number of 1000 tickets sold for this raffle. Ticket sales will stop December 6<sup>th</sup> at 11:59pm EST, or at any point prior to that date when a total of 1000 tickets have been sold. All sales are final. There are no refunds for purchased raffle tickets.

As an "entry" into the raffle, the person to whom the raffle ticket is registered shall be the "entrant". If more than one name is provided on the ticket, the ticket shall be registered to the first name listed, who shall constitute the sole entrant for that ticket. The winning entrant or their respective heir, executor, administrator, agent, representative, successor, or trustee shall be the "winner" of the prize. Payment to or delivery of any prize will be made to the winning entrant. The winning entrant must supply his/her social security number before the prize is tendered. It is the sole responsibility of the winning entrant to allocate the prize to other participants in case of a multiple person entry, and the winning entrant shall hold harmless Oxford Wildcat Booster Club, Inc. in case of conflicting claims or disputes among multiple claimants.

**Drawings**

**Early Bird Drawing:**

An Early Bird raffle drawing for three - \$500 prizes will take place on September 30<sup>th</sup> at the Oxford Wildcat Booster Club Store, 15 E Burdick, Oxford MI., between 6pm and 8pm. Tickets must have been purchased by 11:59pm on September 29<sup>th</sup> to be eligible for inclusion in the Early Bird drawings. All eligible ticket stubs will be deposited in a raffle drum and three tickets will be drawn with at least two Oxford Wildcat Booster Club Board Members present. All ticket stubs, including the Early Bird winning ticket stub, will then be stored until Thursday, December 9<sup>th</sup>, 2023 for the Grand Prize drawing.

**Grand Prize Drawing:**

All eligible ticket stubs sold prior to 11:59pm December 6<sup>th</sup> (including the Early Bird winners) will be deposited in a raffle drum on December 9<sup>th</sup>, 2023 between approximately 6:00pm and 8:00pm EST. Five (5) ticket stubs will be drawn from the raffle drum to determine the winners of the first five cash prizes as described below. After the fifth drawing, all five previously drawn ticket stubs will be returned to the drum (to be included with all other eligible tickets sold) for the Grand Prize drawing. The Grand Prize drawing will be the final drawing.

If any of the drawings cannot occur on the scheduled date(s) due to weather, power failure, or any other unforeseen circumstance, the drawing will take place at the Oxford Wildcat Booster Club Store on the next business day, with at least two Oxford Wildcat Booster Club Board Members present.

**Prizes**

Three Early Bird prize winners will receive \$500 each.

Except as provided below, the first Five prize winners drawn on December 9<sup>th</sup> will receive \$500 each.

Except as provided below, the Grand Prize winner on December 9<sup>th</sup> will receive their choice of:

- A two-year prepaid lease on a 2023 RAM 1500 TRADESMAN CREW CAB, plus \$5,000.  
OR
- A two-year prepaid lease on a 2023 JEEP WRANGLER 4-DOOR SPORT ALTITUDE, plus \$5,000.  
OR
- A cash prize of \$17,500.

The prepay lease is based on tier 1 approved credit and shall have a limit of 10,000 miles per year. For mileage in excess of this limit, the prize winner (lessee) shall be responsible for payment of a mileage overage fee of \$0.25 per mile. The Approximate Retail Value (ARV) of the grand prize is \$20,000, and lease pricing was established based on GLBC rebates and pricing matrix. Oxford Wildcat Boosters Club Inc. may substitute a prize of equal or greater value if the advertised prize becomes unavailable for any reason.

*\*NOTE: If fewer than 800 total raffle tickets are sold by 11:59pm December 6<sup>TH</sup>, the December 9<sup>th</sup> Grand Prize drawing will revert to a cash prize raffle, with cash prizes equaling; 1% of ticket sales proceeds to each of the Five winners, and 35% of ticket sales proceeds to the Grand Prize winner.*

All winners will be notified by phone, electronic mail and/or U.S. mail. The raffle winners must claim their prize(s) within seven (7) days of the raffle drawing date or a new winner will be selected. It is the responsibility of the ticket purchaser to provide a valid email, street address and phone number for notification. If a winner does not confirm acceptance of the prize within the time limit above, another ticket will be drawn.

All early bird and cash prize winners are responsible for any applicable local, state and federal taxes and compliance with any local, state and federal applicable laws.

Grand Prize winner will need to formally choose his/her prize option and confirm acceptance of their prize within seven (7) days of the raffle drawing date or a new winner will be selected. If the "\$17,500 cash option" is chosen, federal and state income tax withholding will be deducted from the prize. If the "vehicle plus \$5,000 cash option" is chosen, federal and state income tax withholding will be deducted from the prize. Any other fees, taxes, assessments and like charges associated with the prize, including but not limited to destination charge, plate fees, title, registration, and insurance are the responsibility of the Grand Prize winner. Prepay lease pricing is based on the winner qualifying for tier 1 approved credit, and winner must have a valid driver's license and provide full coverage insurance that meets leasing company requirements. Winner must complete a W-9 form before receiving the prize. If the winner does not qualify for the lease, they will automatically receive the "\$17,500 cash prize option".
